Wholesale Purchase Agreement

High Hopes Rubber Stamps will only sell retail to qualified retailers who own a brick and mortar retail shop. We do this to help protect our retailers investment in their shops, so they do not get undercut by wholesale buying "clubs".

This requirement for our retailers to have a brick and mortar shop will be waived for the following circumstances:

A) Retailers purchasing stock to sell at a craft show where two or more of each image is purchased. Minimum purchase required.

B) Special craft classes purchasing any single image, or all images used, in quantities of five (5) or more. No minimum purchase required.

Currently we also ask that if a retailer has an online store that they do not promote or sell High Hopes Stamps via their online store or Ebay/Auction website. This policy of no online sales will be in effect from October 1, 2005 - October 1, 2006 while High Hopes Rubber Stamps is establishing our online website, and priority in search engine results.

High Hopes Rubber Stamps guarantees to sell our Mounted and Unmounted Rubber Stamps at FULL RETAIL via our online website, with the exception of a twice annual sale of 25% off. We make this guarantee to protect our retailers investments, assuring them that they will not be undersold. High Hopes Rubber Stamps will however sell mis-marked merchandise, or discontinued stamps (ie: seconds), both mounted and unmounted, via our Ebay Auction site.

High Hopes Rubber Stamps will keep a list of our qualified Retailers on its website to direct customers to their local suppliers, helping our retailers to promote their business.

All orders are made to order, please allow 3-5 days for processing. This time may be longer during peak holiday seasons, you will be

notified. Any shortages will be refunded, and you will be asked to re-order.

High Hopes Rubber Stamps only sells mounted rubber stamps wholesale. We do not wholesale Unmounted Rubber Dies. Our wholesale prices are 50% off retail. There is no per image requirement on retailers who own a brick and mortar sales establishment. There is however an opening order requirement of \$150.00 Cdn. , and re-orders of \$100.00 Cdn. Payment is to be made in full before shipment either by Check or MO (wait until clear before ship.), Email Money Transfer (Certapay), or you can use your credit card by remitting payment via Pay Pal, to: highhopesstamps@sympatico.ca.

All orders are shipped insured via Canada Post, unless it is less expensive to use UPS/UPS International. All shipments are at actual cost + \$2.00 handling/packaging fee. IF merchandise is damaged in shipment, we will process the claim as per the carriers requirements.

We only accept the return of manufacturers defect. If an item has a manufacturers defect, we will replace it at our cost. Please contact us at: highhopesstamps@sympatico.ca to report any defects and get a return authorization (MD) number.

Our terms are as follows:

We need to have on file:

- 1). A copy of a retailers resale permit with tax ID number.
- 2). Proof of brick and mortar shop. Proof can be a photo of the store front, copy of store ad in the phone book or local sales paper, copy of a lease agreement or utility bill in the store name.
- 3). This signed agreement (original, or fax, you keep a copy for your records)
